**Services:**

**Pricing & Billing:**

An invoice will be provided. Fifty percent of the total trip cost is due at the time of reservation (unless it is less than 30 days before trip departure in which case the full amount of the trip cost is due). Balance in full is due 30 days before trip departure. No refunds will be issued.

You may transfer without penalty to another trip date at least 30 days or more before your scheduled trip departure date. Trip must be rescheduled to a date with in one year of your originally scheduled trip.

Services provided by ASGCT that are outside of the scope of services outlined in the “Itinerary” will be billed on a time and materials basis. Materials will be billed using actual prices and personnel and other services will be billed using ASGCT’s then current pricing.
